



U.S. firearms sales February 2021: A slow-down?

(GREENVILLE, SC, USA & HALIFAX, NS, CANADA) – *Small Arms Analytics & Forecasting* (SAAF) estimates February 2021 U.S. firearms unit sales at very nearly 1.5 million units, a year-over-year increase of 10% from February 2020.

SAAF's firearms unit sales estimates are based on raw data taken from the FBI's National Instant Criminal Background Check System (NICS), adjusted for checks unlikely to be related to end-user firearms sales. For example, while the FBI's raw numbers (for February, some 3,394,895) increased year-over-year by 22%, they cannot be taken at face value as large numbers of background checks are unrelated to end-user sales. As a case in point, in February the state of Illinois conducted about 865,000 so-called permit checks and rechecks alone whereas end-user unit sales at firearms retailers likely amounted to about 40,000. SAAF makes certain other adjustments to the data based on retailer reports and other information; nonetheless, the estimates still likely understate the true number of sales.

SAAF Chief Economist Jurgen Brauer comments that "while the February 2021 number of nearly 1.5 million firearms sold is large, nonetheless it is smaller than for February 2013 (1.7 million) and February 2016 (1.6 million) even as the Biden administration formally announced last month that it would start reconsidering federal firearms-related legislation. Handguns continue to outsell long-guns, in February by a ratio of about 1.6-to-1."



CHART 1: SAAF-seasonally adjusted estimates of U.S. firearms unit sales (Jan. 2010 to Feb. 2021)



Notes: Vertical reference lines are drawn for December of the even years (2000, 2002, etc.). Unusual demand spikes can be observed following the terror attacks of 9/11/01, the elections of Mr. Obama (2008 and 2012, the latter coupled with the Sandy Hooks Elementary School shooting in December 2012), the San Bernardino, CA, shooting in December 2015 and Mr. Obama's subsequent and nationally-televised "tearing up" over his inability to do much about firearms violence in the U.S., the Orlando, FL, nightclub shooting in June 2016, covid-19-related fears and pronounced racial unrest for much of 2020, and the confirmation and inauguration turmoil surrounding Mr. Biden's presidency in January 2021.
